## **Learning Outcomes**

Students will ...

- 1. Build a compiler for a nontrivial programming language.
- 2. Specify the lexical and syntactic structure of a language using regular expressions or equivalent representations, and context-free grammars.
- 3. Specify a type system for a language including type equivalence, and use it to correctly type check expressions in a language.
- 4. Apply fundamentals of storage allocation strategies toward run-time management of data.
- 5. Generate correct assembly code for simple expressions and statements in a programming language.
